The management of the project offered an unusual challenge because of the complex structure and funding. Although the construction contract was between Anschutz entertainment Group and the contractor, source of funding was from five utilities, subsidy donor and Anschutz Entertainment Group under various contracts that set out the respective responsibilities and reporting requirements. This meant that allocation of responsibility for changes and related costs had to be allocated in agreement with the various parties involved in addition to the contractor and Anschutz Entertainment Group. ECS managed this challenge well.

- · Coordination of the project participants of the city utilities
- Supervising and checking the quality of the execution of the Joint Venture Arge Arena Areal
- Schedule and budget control
- Coordinating and controlling the correct invoicing w. r. t. subsidies

The detailed and continuous scheduling supervision along with the necessary correspondence it was possible to reduce the time frame for execution of the development by 4.5 months.

The detailed quality control became apparent during the formal handover procedures, since only very few defects were listed. These few defects ensured that the individual utilities and the city were able to take over the finished product into their jurisdiction at the same time as the formal handover from the contractor.

Based on a focused claims management and searching for alternative methods and materials for execution it was possible to achieve significant savings for the project.

Even though the final account has not been finalized it is clear that there will be savings to the budget for the contract and that the final amount invoiced will be less than the tendered values.

The Anschutz Entertainment Group expresses their appreciation to ECS Baubetreuungs GmbH for a job well done and for their fair and accurate cooperation on the project.
